WHO CAN ENTER

ANYONE! For 2017, cash premiums and ribbons will be awarded to exhibitors who are 6 through 19 years of age. All married exhibitors are classified as adults. There will be NO adult Open-Class animal exhibitors. Tiny Tot and Future Genius (5 yrs. & under) and Adult entrants are eligible for ribbon awards only. Special needs individuals who enter indoor exhibits, including posters and demonstrations, will also be eligible for cash premiums and ribbons.

PREMIUM CHECK PICKUP TIMES:

1. Premium checks MUST be picked up on **MONDAY, AUGUST 21, 2017**– 5:00pm – 7:00pm at the Silvana Viking Hall. Leaders can pick up checks for their club, **OR:**

3. **We will not be responsible for any unclaimed checks: they will be voided after 90 days.** All unclaimed checks will be designated to a fair building project.

- All entries are judged according to the Silvana Community Fair Rules and Regulations.
- Superintendents are not eligible to judge in their own departments.
- All projects in all divisions in our fair book are open to 4-H, FFA, and Youth.
- Project Superintendents, under the direction of Fair management and staff, shall have charge of the department to which he/she may be assigned.
- We encourage Originality and Quality!
- Our Fair Management reserves the right to accept late entries if such action would not cause injury to other exhibitors.
- Our Fair Management reserves the right to remove any exhibit falsely entered, or deemed unsuitable or objectionable.
- Our current Fair Year is July 31, 2016 to July 28, 2017 (Inside Exhibits July 31, 2016 to July 24, 2017).

EXHIBITOR’S RISK – Exhibitors shall be solely responsible for themselves and their property at the fair. Neither the Silvana Community Fair Board, nor its representatives, or volunteers, agents or property, shall be responsible to the exhibitor for loss by fire, theft, damage, delay, mechanical failure, or any cause whatsoever, while the exhibitor and the exhibitor’s property, is in transit, at the fair, or while being moved into or out of the fair. Our Fair provides no restitution for loss or damage.

Health Precautions

The Silvana Community Fair takes precautions to help prevent the possible spread of disease. Animal exhibitors are allowed to show in only ONE LIVESTOCK DIVISION (Divisions # 1-11). We also ask that exhibitors be vigilant with their biosecurity measures. We suggest that you haul different species of animals separately, disinfecting trailers between loads if hauling another species. If spectators want to pet your animal, politely direct them to the petting zoo. If you have questions, please contact your superintendent or a fair board member.

NO EXHIBIT (LIVESTOCK OR INSIDE EXHIBIT) SHALL BE RELEASED BEFORE 5:00 pm ON SATURDAY. A VIOLATION OF THIS RULE WILL PLACE PREMIUMS SUBJECT TO CANCELLATION!

LIVESTOCK EXHIBITORS

ATTENTION: PARENTS / EXHIBITORS / LEADERS ---FAIRGROUNDS are at VIKING HALL!
 This is a Community Fair. We need YOUR help in setting up AND taking down! These rules are MANDATORY for SHOW!

1. Parents / Exhibitors / Leaders MUST help with set-up OR take-down in order for you to Show & Receive Premium! Children too young to help should have a parent or adult to help in their place for set-up & take-down.
2. When you arrive, contact Sign In Superintendent, SIGN IN, then go to your area and help out. You sign for yourself ONLY! You do NOT sign for your club. If helping a young child, then sign for his/her name and also sign up in the adult list as well.

BRING HAMMER, NAILS, SAW, LADDER, SLEDGE HAMMER, SCREW GUN, PLIERS, SHOVELS, 9/16” WRENCHES, 9/16” SOCKETS & RACHETS, ETC.

3. After work party is over, SIGN OUT.
4. **If your project area is completed or has enough help, the Superintendent will direct you to another area. If unable to help on night specified, come another night and help in another area.**
5. IF YOU CAN'T MAKE THE SET-UP: then you MUST contact the Superintendent by FRIDAY, July 28th, and sign up for the TAKE-DOWN on Saturday night, July 29, 2017.
6. Be sure to sign in and sign out when you perform your setup or takedown.

PARKING: Please follow SIGNS for Livestock trailer parking and unloading as you come into Silvana. **THE FAIRGROUNDS ARE LOCATED AT VIKING HALL AND DIRECTLY BEHIND IT.**

Livestock Exhibits:

1. Must be owned / leased and under the supervision of the exhibitor.
2. Must arrive in show condition – **ONLY SPOT WASHING ALLOWED.** Animals **MUST** be clipped and ready for show.
3. Must go through Vet check **BY 8:30 AM** with proper **PAPERS AND VACCINATIONS** (if required for your department), AND be free of all warts, ringworm, lice, fleas, footwarts, and signs of illness.
4. Must be properly secured or penned.

PLEASE SEE YOUR DIVISION PAGE FOR SPECIFIC REQUIREMENTS

HERDSMANSHIP: You **MUST** participate to receive premiums. Bring wheelbarrows, pitch forks, etc. to clean up your area during and after the fair. Before you leave the grounds, have the Superintendent check your area and mark off your herdsmanship or **NO** premium will be paid.

- **Exhibitor MUST both Fit & Show and Type exhibit to receive premiums for those points!**
- **Judging rings will NOT be held up. Be on deck on time.** No substitute exhibitors allowed; Exception would be Exhibitor with more than one animal per type class. **NO two exhibitors can Fit & Show and/or Type the same animal. *NO SHARING OF ANIMALS. NO MORE THAN ONE EXHIBITOR PER ANIMAL!!**
- **Proper attire is a MUST for both Fitting & Showing and Type! Follow county guidelines.**
- **There will be NO Adult Open Class animal Exhibitors.**
- **NO HORNED ANIMALS! (with the exception of fiber goats).**
